In this regard, the officials of the Central/State Governments and other Autonomous bodies under the Central/State Government in many instances become members of the CCIM/CCH by contesting the election. Such officials are bound by the concerned Service Rules. Therefore, the Ministry is of the view that the officials of the Central/State Governments & other Autonomous bodies under the Central/State Governments shall mandatorily obtain 'No Objection Certificate' (NOC) from their respective Competent Authorities for contesting the said elections.

Sub: The role of the Members of CCH/CCIM, who owns a medical Institution/College or a part of the Management or Board of the Institute /College-regarding:

The undersigned is directed to draw your attention on the subject above and to say that the Central Councils namely CCIM and CCH under the Ministry of AYUSH have been set up to maintain the Central Register of practitioners and regulate the education and practice and matters related thereto in ISM & H. As the Central Councils are meant to be dedicated to the maintenance of standards and quality in education and practice of AYUSH systems of Medicine the members should be impartial and fair and any conflict of interest should be avoided.

2. In this regard, the Ministry is of the view that whenever the members of the Central Councils who own a medical Institution/College or are being a part of the Management/ Board are part of a visiting/inspecting team to a college, it is likely to result in conflict of interest, considering their role in the Central Councils.

- 3. In view of above, it is decided that no member of the Central Councils, who owns a Medical Institution/College or are in the Management/Board shall henceforth takes part in inspection/visitation of any Medical Institution/College or be included in the Recommendatory Committee of Central Councils for medical Institution/College.
- 4. The Central Councils are requested to communicate the above said decision of the Ministry to all concerned for immediate compliance.
